Zane Robert Taylor v. Zane G. Reed and Telemanagement, Inc.

Type of Claim: Personal injury - motorcycle/auto collision. The plaintiff was riding his motorcycle and was in a left turn lane on West 84th Street near the Fox Street intersection. The defendant was driving his pickup truck. and was exiting a driveway to make a left turn onto 84th Street. The plaintiff claimed that the individual defendant took the right-of-way. The defendants claimed that the plaintiff was negligent for using the left lane as a passing lane, for speeding considering the traffic conditions, and for failing to maintain a proper lookout. The plaintiff alleged that the individual defendant was within the course and scope of his employment with Telemanagement at the time of the accident; the corporate defendant disputed that claim. The defendants said that before this accident, the plaintiff had missed about four years of work because of previous, work-related injuries.

Injuries Alleged: Serious injury to the right leg resulting in below-the-knee amputation. Medical expenses of approximately \$70,000. Economic damages of approximately \$600,000.

Final Demand Before Trial: \$600,000 total (joint demand).

Final Offer Before Trial: \$100,000 total joint offer followed by a \$100,000 offer from Zane Reed according to the plaintiff's attorneys. \$125,000 joint offer according to the defendants' attorneys.

\$471,000 for non-economic losses

\$569,200 for economic losses

60% negligence charged to the defendant Zane G. Reed

40% negligence charged to the plaintiff
